



## K-12 RE-ENROLLMENT CONTRACT – RETURNING FAMILY 2021-22 ACADEMIC YEAR

The undersigned Parents and/or Guardians request to re-enroll (Child's Name) \_\_\_\_\_ for the 2021-22 school year at Odyssey: A Community of Integral Learning, Inc. d/b/a Odyssey School (hereinafter "Odyssey" or "school"), and provide the program, education and other services as prescribed for (Grade) \_\_\_\_\_ for the 2021-22 academic year.

In consideration of Odyssey re-enrolling the above-named child, it is agreed that I/we shall pay to Odyssey, as established by the Board of Trustees of the school, the tuition amount in full by August 1, 2021, or in installments as provided herein. It is understood and agreed that the full tuition is due on or before August 1, 2021, but as a courtesy, Odyssey will offer installment payment plans as outlined below. In consideration of the acceptance of the Enrollment Contract by Odyssey, the undersigned agrees to pay the required fees as specified below. Please initial beside each fee to indicate your agreement.

\_\_\_\_\_ \$250.00 non-refundable Enrollment Fee per student is due with the submission of this signed enrollment contract.

\_\_\_\_\_ 10% non-refundable tuition deposit is due by **February 12, 2021** with the submission of this signed enrollment contract. This deposit reserves a space for your student.

\_\_\_\_\_ Please designate my March 1, 2021 tuition payment for the current academic year as my tuition deposit for the upcoming 2021-22 academic year. I understand this will extend my current payment plan by one month, with the final payment now due on May 1, 2021. The payment on May 1, 2021 will be at the increased tuition rate for the next academic year.

**I/We understand that the obligation to pay the tuition and fees for the full academic year is unconditional and is due August 1, 2021.** After August 1, 2021, no portion of tuition and fees paid or outstanding will be refunded or canceled in the event of absence, withdrawal, or dismissal from the school of the above student.

### Tuition Payment Plans

\_\_\_\_\_ **1 Annual Payment**

One payment for the balance of tuition (after 10% deposit) is paid in full by August 1, 2021. A **5% discount** is available for selecting this option.

\_\_\_\_\_ **2 Bi-Annual (Semester) Payments**

The balance of tuition (after 10% deposit) is divided into 2 equal payments. The first payment is due by August 1, 2021 and the second payment by December 1, 2021. A **3% discount** is available for selecting this option.

\_\_\_\_\_ **4 Quarterly Payments**

The balance of tuition (after 10% deposit) is divided into 4 equal payments. The first payment is due by August 1, 2021, the second by November 1, 2021, the third by February 1, 2022, and the fourth by April 1, 2022.

\_\_\_\_\_ **9 Monthly Payments**

The balance of tuition (after 10% deposit) is divided into 9 equal payments. These 9 payments are due by the 1st of the month beginning August 1, 2021 and ending April 1, 2022.

### Service Hours

Please initial by your preferred option.

\_\_\_\_\_ I/we plan to volunteer the required 4 hours per month at Odyssey. If I/we do not work the required number of hours each month, I/we agree to pay \$10 per hour for outstanding hours not worked. Outstanding hours will be invoiced on January 1 and May 1, 2022.

\_\_\_\_\_ I/we choose to pay \$10 per hour of required service work instead of volunteering. This equates to \$40 per month (\$360 for the academic school year) and will be billed per the tuition payment plan selected above.

**After School Fees**

Available until 6 PM on M, T, Th, F and 5 PM on Wednesdays \$100/month for up to 20 hours. \$275/month unlimited

**Materials Fees and Discounts**

A materials fee in the amount of \$300 (for K-8) and \$1,000 (for High School) will be charged for items such as ACT Aspire Test, field trips, and books.

A tuition discount is offered for siblings. Full tuition must be paid on the oldest student and a 10% discount will be given for all enrolled siblings.

A 10% discount on one annual tuition will be given to any family not receiving financial aid who refers a new family that enrolls for the next academic year. The new family must name the referral family on their initial application to Odyssey for this discount to apply.

**Late Fees, Default and Acceleration:** There is a five-day grace period on installments. If a monthly installment is not received during the grace period, a \$35 late fee will be assessed. In the event of default in payment of any installment hereof as the same becomes due and such default is not cured within 10 days from the due date, and upon 10 days written notice to cure, then in such event Odyssey may without further notice, declare the remainder of contract sum at once due and payable. Failure to exercise this option shall not constitute a waiver of the right to exercise the same at any other time. A 3.5% convenience fee will be added to credit card payments. Returned check fee is \$35.00.

I/we understand that in signing this Enrollment Contract for the upcoming academic year, I/we am/are agreeing to accept the rules and regulations of the School as stated in the Parent Handbook, which may be amended by Odyssey from time to time, and the requirements concerning payment of tuition and fees as described above. Further, I/we understand that our student’s enrollment is subject to the general rules, regulations, and conditions contained in the Student Handbook and other published policies, which may be amended by Odyssey from time to time. I/we understand that Odyssey reserves the right to dismiss any student, or any Parent or Guardian of the student, whose behavior or conduct is determined by the school to be contrary to its values, policies, or regulations. Furthermore, I/we agree to the policy of the school that no student will be permitted to take examinations nor will grades and transcripts be released unless an account has been paid in full.

I/We agree to assume unconditional responsibility for the full annual tuition and fees and the costs collection thereof, including reasonable attorney fees, unless this contract is cancelled prior to August 1, 2021.

Odyssey’s duties and obligations under this Contract may be suspended immediately without notice during all periods that Odyssey is closed because of force majeure events including, but not limited to, any fire, act of God, weather disaster, war, governmental action, act of terrorism, epidemic, pandemic or any other event beyond Odyssey’s control. If such an event occurs, Odyssey’s duties and obligations in this Contract will be postponed until such time as Odyssey, in its sole discretion, may safely reopen. Nothing in this paragraph shall excuse any non-payment of tuition or require Odyssey to refund any portion of the tuition paid.

Re-enrollment, as specified in this Enrollment Contract, may be canceled in writing by parents or guardians without penalty (except forfeit of the non-refundable tuition deposit and fees), prior to August 1, 2021. If re-enrollment is canceled after August 1, 2021, I/we am/are obligated to pay the full annual charges.

All terms and conditions of this Contract shall be binding upon the respective heirs, successors and assigns of the parties. This Contract represents the entire agreement between the parties, and no prior or contemporaneous agreement or understanding inconsistent herewith (whether oral or written) pertaining to such matters is effective. This contract shall be interpreted in accordance with the laws of the State of North Carolina and any action to enforce the terms and conditions herein shall be brought in the state courts located in Buncombe County, North Carolina. The parties agree to waive any right to a trial by jury. This signed Enrollment Contract and full payment of tuition and fees due in accordance with the above schedules must be received prior to your child’s first day of attendance at Odyssey for the grade level specified above.

This Contract is contingent upon the Student’s successful completion of the 2021-22 academic year, both academically and behaviorally, which determination shall be at Odyssey’s discretion.
